

## **HIV and Hepatitis C Testing: Informed consent and giving results**

**2 May to 5 June 2022**

A five week interactive, facilitated online course providing information on current guidelines and best clinical practice for health workers managing clients who present for HIV and/or hepatitis testing.

### **Topics covered include:**

- Current NSW and national guidelines
- Emotional and psychosocial responses to HIV and hepatitis C testing
- Legal issues
- The pre-test interview – what to cover to gain consent
- Risk assessment
- Giving results and providing support
- Application to your work practice

**Who should attend?** All health and non-health providers who will be gaining informed consent for HIV or hepatitis C testing and providing initial result support.

**Requirements:** Participants will need an email address and access to the internet and will be expected to spend approximately 3-4 hours per week for 5 weeks. This course is counted as 15 hours of study, which may be counted towards continuing professional development within your discipline.

- Conduct an interview to gain informed consent for HIV or HCV testing
- Assess and communicate the risk of different types of exposure and how to prevent future exposures
  
- Explain the legal issues relating to testing for HIV or HCV
- Provide information to allow clients to make informed decisions about testing
- Conduct a follow up interview to appropriately communicate the results of testing
- Be able to refer clients to appropriate services
